



Travel and Accommodation Allowance Guidelines

The Travel and Accommodation Allowance (TAA) is a contribution by Skills SA to the costs incurred by employers when apprentices or trainees are required to travel long distances to a Registered Training Organisation (RTO) that delivers their qualification.

This allowance is a **contribution only** and is not intended to cover the total travel and accommodation costs. Any additional travel and accommodation costs incurred as a result of an apprentice or trainee attending off the job training may be the responsibility of the employer (see **Provisions under modern awards** below).

The current payment rates apply to training blocks where the **last day of the training block is on or after 1 July 2026**. To find out the previous payment rates for training blocks where the last day was on or before 30 June 2026, please refer to the historical version of the TAA Guidelines effective 11 November 2025, available on Skills SA's website. Eligibility criteria

To be eligible to receive an allowance, an employer must employ an apprentice or trainee that:

- has an approved Training Contract registered in South Australia, under the *South Australian Skills Act 2008* (SA);
- is required to travel to attend training for their apprenticeship/traineeship qualification, where this qualification is a vocational education and training course; and
- is required to travel in excess of 150 km (round trip) between their normal place of residence and the nearest training venue delivering the apprenticeship/traineeship qualification; and
- resides within a non-metropolitan area of South Australia, unless the travel allowance relates to interstate travel pre-approved by Skills SA. The list of pre-approved qualifications is provided at **Schedule A – Travel and Accommodation Allowance Interstate Delivery List**.

Guidelines

- Employers must **lodge an application online** after the apprentice/trainee has attended the training block being claimed. Employers should make this claim as soon as possible after the training block, but Skills SA will only accept claims submitted within six months of the last day of the training block. The call up notice issued by the RTO must be attached to the application.
- **Travel allowances** are a pre-determined rate based on the distance travelled from the place of residence (Residential Address) of the apprentice or trainee to the closest contracted RTO able to deliver the off-job training:
 - **Intrastate** – 52c per kilometre for the shortest practical route
 - **Interstate** – calculated on a set rate based on an economy airfare
- Residential Address is where the apprentice or trainee normally resides. Residential Address is not the address where the apprentice or trainee lives while away working. For example, if an apprentice resides in Norwood, Adelaide and lives in Olympic Dam while working (works for two weeks at Olympic Dam and one week off home at Norwood, Adelaide), then Norwood, Adelaide is the Residential Address.
- **Accommodation allowances** (weekends and public holidays that occur within a training block will be included for calculating entitlement)
 - **Intrastate** – \$90 per day
 - **Interstate** – \$150 per day for pre-approved training delivered in other states
- No receipts are required for travel and accommodation costs incurred.



- The maximum allowance payable for each apprentice or trainee per calendar year is limited to 10 return trips and accommodation for 48 days.
- If the employer together with the apprentice or trainee selects an RTO that is not the closest **contracted RTO** delivering the qualification, an allowance will only be paid for the distance that would be travelled to attend the closest contracted RTO.
- Allowances to attend off the job training interstate will only be paid where there is no RTO scoped and able to deliver the qualification in South Australia. Qualifications approved for travel interstate can be viewed in **Schedule A – Travel and Accommodation Allowance Interstate Delivery List** at the end of this document.
- Employers will only be eligible for an allowance where the apprentice or trainee has attended the training block being claimed. If an upcoming training block is cancelled or postponed after accommodation has been booked and a deposit paid, the employer and/or the apprentice/trainee should pursue a refund with the accommodation provider. The TAA cannot pay for a deposit that is lost through cancellation. As a due diligence measure, it is suggested that the accommodation provider's refund policy be carefully checked prior to booking.
- All allowances must be paid into a bank account held in the employer's legal or trading name. Payments cannot be made directly to an apprentice or trainee.
- Payments for eligible training blocks will be transferred to the employer's nominated bank account within 10 business days of application receipt.

Provisions under modern awards

Many modern awards require employers to reimburse apprentices for the full cost of them being required to travel to and attend off-the job training, so long as the apprentice makes satisfactory progress. Employers should refer to the award or other industrial agreement on the Training Contract.

The amount payable by an employer can be offset by the amount received through Skills SA's Travel and Accommodation Allowance.

If the award or other industrial agreement in operation is silent on the provision of travel and accommodation arrangements, responsible employers will ensure that their apprentice or trainee is fully supported and is not out of pocket as a result of having to travel to attend off the job training.

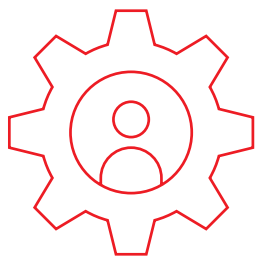

Goods and Services Tax (GST)

GST does not apply to the Travel and Accommodation Allowance.

All claimed amounts must be exclusive of GST.

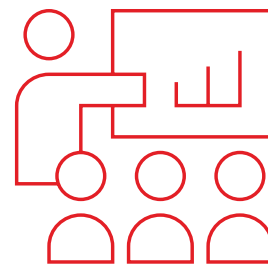


Calculation of Travel and Accommodation Allowance payment rates

The Travel and Accommodation Allowance amounts payable are calculated based on the distance from the apprentice's residential address to the training venue of the closest contracted RTO able to deliver the off the job training.

Residential Address	Training venue of closest contracted RTO	Travel allowance	Accommodation allowance
Metropolitan	Metropolitan	Nil	Nil
Metropolitan / Regional	Interstate - round trip (refer Schedule A – Travel and Accommodation Allowance List)	Adelaide-Melbourne \$600. Adelaide-Sydney \$700. Adelaide-Queensland \$950.	\$150/night.
Regional	Metropolitan/regional - round trip Distance 150km or less	Nil	Nil
Regional	Metropolitan/regional - round trip Distance greater than 150km	52c per kilometre for the shortest practical route	\$90/night
Regional (Kangaroo Island)	Metropolitan/regional - round trip Distance greater than 150km	Kangaroo Island Ferry return \$330	\$90/night

Examples of Travel and Accommodation Allowance payment rates

1. Apprentice A – Interstate travel

Apprentice A is a locksmith apprentice whose normal place of residence is Prospect, which is in the Adelaide metropolitan area. The closest contracted RTO who delivers the required training is in Melbourne and the Department has pre-approved this travel.

After Apprentice A attends each 2-week training block, the employer may claim the following:

Accommodation – 12 nights @ \$150.00/night	\$1,800.00
Travel allowance (Adelaide to Melbourne) – set rate based on economy airfare	\$600.00
Total	\$2,400.00

2. Apprentice B – Nearest contracted RTO

Apprentice B's normal place of residence is Port Lincoln and has selected an RTO in Adelaide. However, the closest contracted RTO who delivers the training is at Port Augusta. Accordingly, Apprentice B is entitled to allowances based on travel from Port Lincoln to Port Augusta. For a 2-week training block, then, the employer of Apprentice B may claim the following:

Port Lincoln to Port Augusta

Accommodation – 12 nights @ \$90.00/night	\$1,800.00
Travel allowance (341km x 52 Cents) X 2 = \$355.00	\$355.00
Total	\$1,435.00

However, had the closest contracted RTO been in Adelaide, the employer of Apprentice B would have been able to claim:

Port Lincoln to Adelaide

Accommodation – 12 nights @ \$90.00/night	\$1,800.00
Travel allowance (650km x 52 Cents) X 2 = \$676.00	\$676.00
Total	\$1,756.00
